Through our "Fast Track" agreements, you are eligible to apply for certification with the State of New York (visit [www.ny.newnycontracts.com](http://www.ny.newnycontracts.com) and follow instructions), or with the NYC Small Business Services (see attached).

Your certificate with NMSDC is valid for a period of one (1) year and will expire on **6/27/2024**. Prior to that time, you will receive a re-certification notice (via email) to reaffirm your continued ownership and control of the firm.
